

The monthly contributions liability is pegged at 10 percent of employees' monthly gross earnings subject to the gazetted monthly contributions ceiling in the year to which the earnings relate. However, employees whose monthly gross earnings are below K15.00 or its equivalent in the old currency are exempted from contributing to the scheme.
